KNOW ALL PERSONS BY THESE PRESENTS, that the undersigned hereby makes, constitutes and appoints Meredith W. Cook, Esq., General Counsel, and Stephen P. Carey, Chief Financial Officer of ANI Pharmaceuticals, Inc. (the "Company"), and each of them, as the undersigned's true and lawful attorney-in-fact (the "Attorney-in Fact"), with full power of substitution and resubstitution, with the power to act alone for the undersigned and in the undersigned's name, place and stead, in any and all capacities to:
